#### CHOA Bylaws Part 2 – 7:

*“Strata Corporation Members shall consist of all Strata Corporations, who have made application for voting membership by means of either a duly adopted majority vote resolution of their Strata Corporation at an Annual or Special General Meeting, or a motion passed by a majority at a Council meeting and have paid the annual fee to join the Association (“Strata Corporation Members”). All owners of strata lots located in complexes that are Strata Corporation Members shall have access to the services of the Association for matters concerning their individual strata lots.”*
